Authors who submit their publication must fulfill the following requirements:

- 1) Be a current member of the IARFC or be approved by the IARFC as a participant in a sanctioned Association event.
- 2) Send in a <u>completed</u> Book Nook Submission Form that includes:
 - a) Topic choice (one)
 - b) Title, Author, Year Published
 - c) Link to the author's book.
- 3) Provide a cover image
 - a) Image size 400 x 400 pixels
 - b) In jpeg or png format
